R. David Bauer, M.D., Orthopedic Independent Medical Examinations

Dr. David Bauer is an active practice orthopedic spine surgeon, practicing in the Dallas area since 1997. Dr. Bauer was certified by the American Board of Orthopedic Surgery in 1990, and re-certified in 2000 and 2010. He is a fellow of the American Academy of Orthopedic Surgeons, a member of the North American Spine Society and was Vice Chief of Staff at Baylor Medical Center Garland where he had admitting privileges. Dr. Bauer performs services as a designated doctor and serves on the TDI/DWC Medical Quality Review Panel and on the Arbiter's Panel. He received his BA in Biology from Columbia College in New York City in 1979, and his M.D. from Columbia University College of Physicians and Surgeons in 1983. Dr. Bauer completed his orthopedic residency at New York University Medical Center in 1988 before serving active duty in the United States Air Force 1988-1991. In 1992, Dr. Bauer completed a Spine Fellowship at University of California and was Assistant Professor of Orthopedics and Chief of the Spine Service at West Virginia University.

Cody Byrns, Founder, Cody Byrns Foundation for Burn Survivors

Cody Byrns is an internationally recognized speaker and a number one best-selling author. In May of 2013, Mr. Byrns' life was drastically changed. While stopped at a red light on the highway, he was rear-ended by a box-truck that did not stop. As a result, he was considered dead until first responders saw his hand move. He received many injuries that day, including severe burns to almost 40% of his body. After years of countless surgeries and rehabilitation, Mr. Byrns has chosen not to allow his scars to keep him bound in bitterness and defeat. Instead, he uses his story to uplift others. His goal is to help people live free from the bonds of scars (physical and emotional), equipping others with the proper steps to walk out of their past hurt and defeat, and run towards their God-given potential. In addition to his speaking career, in 2016, Mr. Byrns founded his own non-profit burns foundation that has been able to help multiple survivors recover.

Aaron L. Cross, D.O., Helena Orthopedic Clinic

Dr. Aaron Cross earned his medical degree from Lake Erie College of Osteopathic Medicine and completed his residency training in Physical Medicine and Rehabilitation at the University of Miami and Jackson Memorial Hospital. Following his residency, he completed subspecialty training in Pain Medicine as a fellow at the University of Miami and Jackson Memorial Hospital. He is a Diplomate of the American Board of Physical Medicine and Rehabilitation. Dr. Cross is board certified in Physical Medicine and Rehabilitation and Pain Medicine.

Paul Gorsuch, M.D., Montana State Fund

Dr. Paul Gorsuch is a Fellow of the American Academy of Neurosurgeons with over 35 years of experience in treatment of spine and cranial injuries and conditions. Dr. Gorsuch is practicing at the Billings Clinic in Billings, Montana and serves as Montana State Fund's Medical Director.


